In case you are interested in this way of nomination, please send your nomination proposals for the student chamber of the Academic Senate of the Faculty of Economics of VŠB-TUO in written form to the chairman of the Election Committee using the appropriate form attached on the election website or to this letter. The candidate's signature certifying consent to candidacy and the appropriate number of signatures of the members of the student part of the academic community are essential requirements¹.

The deadline for submission of candidate applications is no later than **Thursday 4 May 2023, 10:00 a.m.**, which is set by the resolution of the Academic Senate of the Faculty of Economics of VŠB-TUO dated 14 March 2023 and the resolution of the Election Commission dated 29 March 2023

In order to ensure the regularity of the nomination of candidates and the recording of the last changes, the Chairman of the Election Committee will be present on Thursday 4 May 2023 at 10:00 a.m. in room A 419, where he will also, if desired, confirm the acceptance of the submitted nomination papers by the submitters.

The submitted nomination papers will be published on the above-mentioned website without undue delay.
