The applicant is obliged to deliver the aforementioned documents by June 30, 2023; or a document proving the fulfillment of the condition of proper completion of studies in (follow-up) master degree program if education was obtained abroad (not applicable equivalent documents, e.g. from the Slovak Republic).

If the assessment of previous education will take place within the admission procedure, it is necessary to deliver the required documents in paper form (address: VSB-TUO, EKF, odd.161, Havlíčkovo nábřeží 38a, 702 00 Ostrava, see https://www.vsb.cz/en/university/university/services/recognition-of-foreign-education/) no later than 30 days before the deadline for delivery of attachments to the electronic application (till May 31, 2023).
