Proceedings of the 1st, 2nd, 3rd and 4th ICEI 2012, 2014, 2016 and 2018 *have been indexed* in the Conference Proceedings Citation Index (CPCI) accessed via Web of Science™.

- to send abstract and paper in deadlines together with honour and originality declaration and protection of personal data
- to follow templates and guidelines format and fulfil conditions of the review process
- to pay conference fee in time
