All abstracts and papers must be written in **English language**.

All papers that will successfully pass double-blind review process will be published in printed conference proceedings. The proceedings will be sent with request to be indexed in the **Thomson Reuters Conference Proceedings Citation Index** accessible at Web of Science™.

have been indexed

in the Thomson Reuters Conference Proceedings Citation Index **accessed via Web of Science™**.

Necessary conditions for accepted papers in the conference proceedings: abstract and paper must be sent in deadlines together with honour and originality declaration; abstracts and paper must follow the templates and guidelines format and fulfil conditions of review process; conference fee must be pay in time.

The templates are available on the conference website. There are 20 minutes for paper presentation, including questions and remarks. For paper presentation, standard audio visual devices will be available (data projector, flipchart).

The conference languages: Czech, Slovak, Polish and English.

Requirements for active participation at the conference: presentation of paper in chosen conference language based on registration. PowerPoint template of presentation must be in English language.
